- Up to \$7,500 in rebates

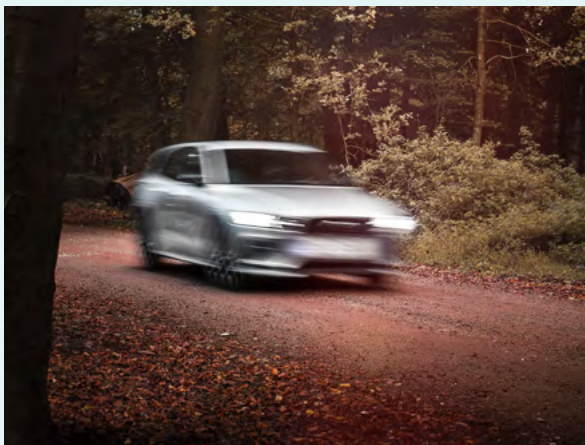
### ELIGIBILITY

- Supplemental Nutrition Assistance Program (SNAP) for food assistance, or
- Temporary Assistance for Needy Families (TANF) for cash assistance, or

#### *Moderate Income*

- Adjusted Gross Income (AGI) up to \$70,000 for individual filers and \$100,000 for joint filers

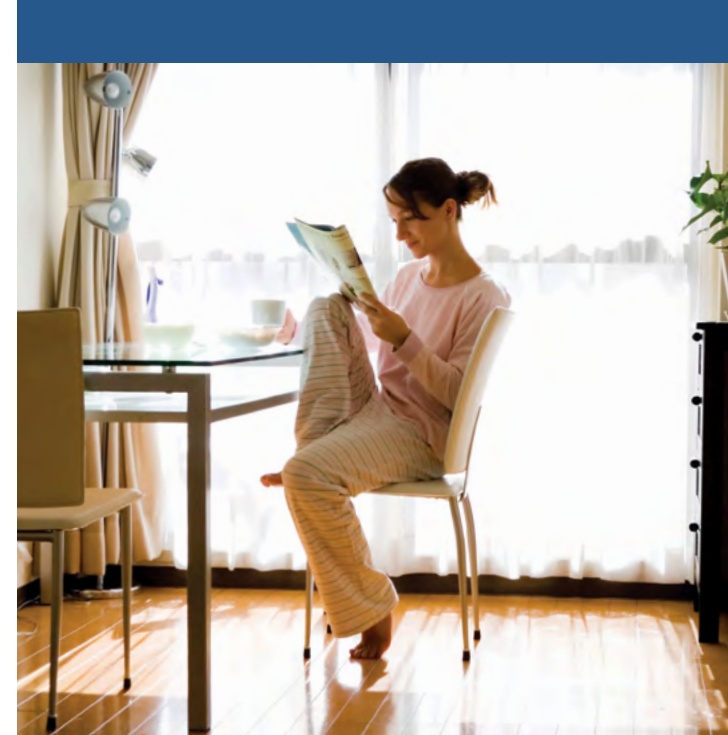

## HEAT PUMP WATER HEATER

Tens of thousands of Mainers own heat pump water heaters. They're popular because they produce lots of hot water, can save more than \$5,000 over their 10-year life, and with current incentives, can be less expensive to buy than traditional electric water heaters.

### REBATES

- Free heat pump water heater, including installation

### ELIGIBILITY

- Home Energy Assistance Program (HEAP), or
- Supplemental Nutrition Assistance Program (SNAP) for food assistance, or
- Temporary Assistance for Needy Families (TANF) for cash assistance, or
- MaineCare for medical insurance coverage

### OTHER REQUIREMENTS

- Basement space with a 6-foot ceiling\*
- Water heater in the basement
- Must call 866-376-2463 to be assigned a participating installer

\* *Mobile homes or homes on a slab foundation do not qualify.*

## HEAT PUMP

Over 100,000 heat pumps have been installed in Maine and they are now more common than oil heat in new homes. They are the most popular heating system across all of Efficiency Maine's rebates because they offer highly efficient heating, air conditioning, and dehumidification.

### REBATES

- 80% of project cost up to maximum rebate of \$8,000 for low income
- 60% of project cost up to maximum rebate of \$6,000 for moderate income

### ELIGIBILITY

#### *Low Income*

- Home Energy Assistance Program (HEAP), or
- Supplemental Nutrition Assistance Program (SNAP) for food assistance, or
- Temporary Assistance for Needy Families (TANF) for cash assistance, or
- MaineCare for medical insurance coverage

#### *Moderate Income*

- Adjusted Gross Income (AGI) up to \$70,000 for individual filers and \$100,000 for joint filers

### OTHER REQUIREMENTS

## INSULATION

Adding insulation and reducing the amount of air that leaks in and out of your home can be a cost-effective way to reduce heating costs and improve comfort.

### REBATES

- 80% of project cost up to maximum rebate of \$8,000 for low income
- 60% of project cost up to maximum rebate of \$6,000 for moderate income
